Thank you for considering the City of Westminster Recreation and Parks Summer Camp Program as your child's destination for summer fun. We value our relationship with you, therefore wanted to make you aware of the following changes that have been made:

COVID Safety Plan:

There are 10 weeks of camp but there are 5 sessions you can register for. Each session is 2 weeks long.

Camp Cost:

This year camp tuition cost is \$135 for Residents and \$145 for Non-Residents a week. **You must call in to register, there is no online registration this year.

Security Deposits:

Upon registration a \$45 security deposit is due for each week of camp. This is included in the overall camp cost and will be credited to your tuition balance. The purpose of this deposit is to hold your child's spot for the camp weeks you wish to attend. The deposit is refundable or transferable to a different camp week until May 10th. Starting May 11th all security deposits paid WILL NOT BE refundable or transferable to a different camp week. NO EXPECTATIONS. The security deposit cannot be added to a payment plan, it must be paid in full upon registration.

Payment Due Dates:

Payment in full is encouraged at least 7 days prior to your child's camp start date. If you have not paid in full by drop off the Monday of your child's first week of camp your child will **NOT** be allowed to attend and your security deposit will not be refunded or transferred to a different week.

Early Drop off/Late Pick up Fees:

Campers are to be dropped off at 9am and picked up at 4pm. If you drop your child off before 9am then you will be charged a \$15 before care fee on the first offense. If it is repeated you will be charged an additional \$15 for each occurrence during that week. If you pick your child up

after 4pm then a \$15 after care fee will be charged on the first offense. If it is repeated, you will be charged an additional \$15 for each occurrence during that week. If your child is left in after care after 6pm a fee of \$1 per minute will be charged for every minute you are late.

To help avoid early/late fees it is suggested that you consider enrolling in Before and After Care program.

C.I.T. Hiring Process: If you have a child 13 years and over interested in becoming a C.I.T. (Counselor-In-Training) please note the following changes:

All interested participants are required to: fill out and submit a C.I.T. application, schedule and attend a brief interview, attend a mandatory C.I.T. training session, display a positive attitude and general interest in working with children enrolled in the City of Westminster's Summer Day Camp Program.

C.I.T. Session:

Cost: \$70 for Residents and \$80 for Non-Residents with a \$25 non-refundable/non-transferable security deposit/ camp week includes all field trips and snacks

Applications Due: Monday, May 10

Interviews: May 17-21

Mandatory C.I.T. Training Session: Monday, June 7 at 5:00pm

C.I.T.'s will earn 20 student service learning hours per session

Available weeks (Must commit to both weeks):

Week 1 & 2: June 21 - June 25 & June 28 - July 2

Week 3 & 4: July 5 - July 9 & July 12 - July 16

Week 5 & 6: July 19 - July 23 & July 26 - July 30

Week 7 & 8: August 2 - August 6 & August 9 - August 13

Week 9 & 10: August 16 - August 20 & August 23 - August 27

A maximum of six C.I.T.'s will be selected for each week of camp. If your child is chosen they are expected to display exceptional behavior, attitude and work ethic. If C.I.T.'s fail to perform as a positive role model they will be asked not to return.
